Sir/Madam,

With reference to the subject mentioned above, I would like to inform you that Registration of students of Class IX (Nine), 2020 for the Schools located at District Headquarters can be done through **ONLINE by logging into MBOSE website www.mbose.in from 24th February, 2020 upto 15th May, 2020.** Fees will be Rs.250/- (Rupees two hundred and fifty) only per student as approved by the Board vide **Agenda No.10 on 27th March, 2017.** Online registration can also be utilized by all the institutions where internet facility is available. Fees can also be paid online. In case the school does not possess the online transaction facility: they will have to generate the e-challan and payment can be made directly in the bank. Payment receipt will have to be uploaded or sent to **mbose_tura@rediffmail.com** for verification.

Registration for Class IX (Nine) students from the schools located outside the District Headquarters can also be submitted in offline (manual) mode. Registration forms will be available at Meghalaya Board of School Education, Tura/Shillong/Jowai Office from **24th February, 2020** on payment of Rs.10/- (Rupees ten) each only and the Registration fees will be Rs.250/- (Rupees two hundred and fifty) only per student.

The Heads of all the Secondary Schools are requested to submit the forms with fees on or before **15th May, 2020.** The fees may be paid in bank draft payable in favour of "**The Executive Chairman**", Meghalaya Board of School Education, Tura. Fees can also directly deposited into MBOSE Account and payment slip should be attached along with the forms.

However fees and forms will be accepted upto **29th May, 2020,** with a late fine of Rs.300/- (Rupees three hundred) only per student, as approved by the **Board vide Agenda No.10 on 27th March, 2017.**

The Heads of all the Secondary Schools are to submit the forms in Form- 3A in two copies for male and female separately.

Kindly note that registration forms must be submitted only in Meghalaya Board of School Education, Tura/Shillong/Jowai office in person. Forms will not be accepted if submitted through mail/registered post/courier.
